RATIONALE

Maternal health remains a global public health priority, requiring continuous improvement in surveillance, evidence generation, and translation of research into clinical practice and health policy. Severe maternal morbidity, maternal near miss events, and preventable maternal mortality continue to challenge health systems, even in high-resource settings. In this context, international obstetric surveillance systems represent essential tools for generating robust evidence on rare and severe pregnancy complications, supporting quality improvement, and informing prevention strategies and policy decisions.

The INOSS–ItOSS international meeting: maternal health between evidence, health systems and care practices provides a multidisciplinary forum for the exchange of scientific knowledge and experiences among researchers, clinicians, public health professionals and policymakers engaged in maternal health. Through the integration of perspectives on surveillance, health system organization and models of care, the meeting promotes reflection on current challenges and opportunities to improve maternal outcomes, reduce inequalities and strengthen the translation of evidence into practice. The event is particularly relevant for fostering international collaboration, sharing innovative approaches to maternal health monitoring and care, and supporting coordinated actions aimed at improving the quality, safety and appropriateness of maternal care.

AIMS

The meeting aims to promote scientific exchange and strengthen international collaboration on maternal health, with a focus on the relationship between evidence generation, health systems and care practices. It intends to provide an opportunity to discuss current evidence and methodological developments in obstetric surveillance, share experiences and good practices in prevention and management of severe maternal complications, and encourage dialogue on priorities for research, surveillance and quality improvement in maternal care.
