Induction of Labour Study

As mentioned in the previous newsletter, the next study will be investigating outcomes for women who are admitted to a midwifery unit following a component of induction of labour (IOL). We have now received the necessary approvals to begin this study and are pleased to let you know that this study is now open.

Data collection for the IOL study begins on 1st July 2025 and you will receive your first report request email on 1st August 2025.

What is a 'case' for this study?

A case will be any woman who was admitted for labour care to the midwifery unit after having any component of induction, whether this induction took place elsewhere or in the midwifery unit. Please include women who had artificial rupture of membranes (ARM) as a component



of induction. Do NOT include women who only had ARM to augment labour.

Due to the nature of this topic and the way that the data will be analysed, not all cases in this study will require a control to be identified. As in previous studies, please report all women meeting the case definition above.

In the data collection form for each case, you will be asked to consider whether the woman was **transferred** to the obstetric unit before labour was established (e.g. for further intervention). For women who are transferred before labour was established, we do NOT require a control to be identified, and we will be collecting only a small set of data items. For all other women, i.e. those who establish labour in the midwifery unit after a component of IOL, we will require a control to be identified and full data collection as in previous studies. The data collection form will make clear whether a control is required based on the information you enter.

Your role as a reporter

As a reminder, the figures you need to report each month are:

- The number of women who were admitted for labour care in the midwifery unit in the previous month
- The number of 'cases' in the midwifery unit in the previous month
- The number of **births in the midwifery unit** in the previous month

Even if your unit does not admit women following a component of induction as standard and/or you don't have any cases to report in a given month, please still report 0 cases along with how many women were admitted to and how many women gave birth in your unit. We need to make sure that we get data from every unit, including those that never have any 'cases'. This means we can describe accurately how many units do, and don't, admit women following IOL so we can work out what proportion of women admitted to midwifery units have had IOL.

For each case you report, we ask you to complete the data collection forms online. This is done via a database called OpenClinica. You will need login details for this but if you don't have an account or can't remember your details, don't panic! Please contact the UKMidSS team once you report your first case and we can organise access.
